CLIMATE agenda: Cross-border cooperation in Brazil's Legal Amazon [BLA]

Interview data with **strategic German stakeholders** in the context of cross-border cooperation projects in **BLA**¹ that deal with climate from a subnational approach.

WHICH ARE the main themes and challenges perceived by the interviewees when it comes to cooperation projects from a subnational approach?


Top Themes

Bioeconomy | REDD+² | Empowerment of Traditional Communities & Indigenous People Top Challenges

Local political order | Local technical capacity | Local articulation capacity

>> PERSPECTIVE

Comparing the "top themes" perceived by the interviewees as a priority to the **programs foreseen** in the Climate State Policies in BLA, **there is a certain compatibility, at least for the REDD+ programs and Environmental Services scopes**. On the other hand, the weight they give to "the Empowerment of Traditional Communities & Indigenous People" is not reflected in the state policies analyzed: only 2 of the 29 programs are explicity dedicated to that aim³.



SUBNATIONAL APPROACH

When asked **for which state** they have heard about and/or are somehow familiar with an existing Climate State Law in BLA, they mainly cited the State of **Amazonas**, followed by **Pará**.


Around **11% had no awareness** at all of any subnational climate law in place for the region.



>> NEAR FUTURE

The graph shows the level of "Reliability & Optimism" among the German interviewees

concerning the Brazilian government's actions and commitments - on both a federal and a subnational level - to face the climate crisis in BLA. Responses like "reasonable" and "high" were mostly made regarding a subnational level.



CONSIDERATIONS



Although topics considered to be priorities vary from one actor to the other, it is clear that there is **plenty of room to continue cross-border cooperation between Germany and Brazil**. This research sheds light on the possibilities of doing so considering a **subnational approach**, which in fact seems to be a more **promising channel** for the moment based on the interviews carried out and as reflected in the graph opposite.
